RESEARCH AND TEACHING INTERESTS

Research: My research interests are at the intersection of managerial accounting and labor economics. I study how the design of compensation contracts, financial incentives, and performance-measurement and evaluation systems influences the behavior of managers, employees, and investors. I investigate these questions primarily through experimental economics methods but also use survey-based and field experiments.

Teaching: At Cornell, I teach the course “Managerial Accounting and Reporting” for MBA students. I use a mix of cases, short lectures, and group projects to cover cost analysis, performance management, and other core managerial accounting concepts. Previously, I taught applied courses on “Strategy and Managerial Accounting” for undergraduate students.
